### **Building Committee Update - January, 2017**

Your Forest Lakes Building Committee has been working diligently to competitively select the contractor for our new fire station. Committee members Chief Rodriquez, John Hennessey, Quentin Tolby, Tom Cumiskey and John Walstrom initiated the competitive process by issuing a Request for Proposal/Statement of Qualifications in early December. There were a total of five responses to our request. A Selection Committee was established to down select to three finalists. The Selection Committee consisted of the building committee members, Citizen-at-Large Cal Phillips and our Architect, Bruce Scott. The Selection Committee heard the presentations from the three finalists in early January, and announced the contractor of choice on January 9<sup>th</sup>.

In his letter notifying the winner, Caliente Construction, Chief Rodriquez stated:

*“The FLFD Selection Committee is pleased to announce that Caliente has been chosen the contractor of choice to partner with HD-Architects and the Forest Lakes Fire District to move forward with the construction of the new fire station. Caliente’s strong history of metal building construction, bringing successful fire station projects to fruition, and the Forest Lakes’ connections offered by Caliente’s owner, Lorraine Bergman, and your Project Manager, Jeff Schaffer, were important factors in the decision process.”*

One of the first orders of business will be discussions for a Pre-Construction contract, which will lead into the development of a mutually agreeable Guaranteed Maximum Price (GMP). Once the GMP is agreed upon, we will move forward with signing the Construction contract (March 1<sup>st</sup> target date.)

Current discussions are based on having ground breaking early this year, foundation work completed before the monsoons hit, having the building dried-in before the winter snows arrive in earnest, and occupying the new facility by late Spring 2018.
