

**Forest Lakes Owners Association**  
**Minutes of the Monthly Board Meeting**

**June 18, 2011**

**1. Call to order**

The monthly meeting of Forest Lakes Owners Association was called to order at 3:03 by Karen Foncannon. She led the group in the Pledge of Allegiance.

**2. Approval of Minutes from last Meeting**

**3. Treasurer's Report**

Jane Cummins read the Treasurer's Report. There is \$700.00 cash on hand, \$9,235.88 in the checking account, \$10,000.00 in the contingency fund, \$27,175.22 in the NB Money Market and \$96,776.02 in four CD's for a total of \$143,887.12. A motion was made by Jan Walls to accept the report and was seconded by Mack Hume.

**4. Fire Department Auxiliary**

Jan Walls reported that the Ice Cream Social held on May 29, 2011, the Sunday after the Pancake Breakfast, was quite successful and that another Ice Cream Social will be held on July 3rd, the Sunday after the event at Bugles. The Ice Cream Social will be at the Fire Station from 2:00 to 4:00 p.m.

Jan also said that the Auxiliary will be putting out a Forest Lakes Cookbook next Spring or Summer and that she would really appreciate any recipes that residents would like included. Jan said the Piece Makers will sell raffle tickets on July 2<sup>nd</sup> in front of Bugles and that the quilt to be raffled off will be on display.
